**Psoriasis Patients**

**Study drug and design:**

AbbVie is testing an investigational drug, which is not approved by the Food and Drug Administration (FDA) or any health authority and is not currently available on the market. The objective of this study is to assess the safety, tolerability, pharmacokinetics (the amount of drug absorbed into your blood stream and how your body handles the drug) and effectiveness of the drug in people with moderate to severe psoriasis.

**Minimum Subject Selection Criteria:**

*YOU may be eligible to take part in this clinical study if you meet the following conditions:*

- ◆ Men and women 18-75 years old, in general good health.
- ◆ Have a clinical diagnosis of moderate to severe psoriasis for at least 6 months.
- ◆ Females must be permanently surgically sterile or postmenopausal for 1 year.
- ◆ Average weight for height (BMI 18.0 to 40.0).
- ◆ Must not require the use of rosuvastatin (Crestor). If taking atorvastatin (Lipitor) or simvastatin (Zocor) the dose must be 20 mg/day or less. Other cholesterol lowering medications are allowed.
- ◆ No history of gastrointestinal surgical operations including removal of the gallbladder.
- ◆ No history of any clinically significant sensitivity or allergy to any medication or food.
- ◆ No history of drug or alcohol abuse for 6 months.
- ◆ Do not smoke or if you do smoke, it is 1 pack per day or less.

**Screenings at ACPRU in Grayslake**

**Screening dates:** *(To find out if you are suitable to take part in this clinical study)*

- ◆ Screening ongoing. Call for appointment time, Monday-Friday.
- ◆ **Additional screening dates may be available.**
- ◆ Screening appointments are between the hours of 08:00 a.m. and 11:00 a.m. and take approximately 3 hours.

**Study dates:** *(Please note that these dates and times are subject to change)*

**Must complete all follow up visits.**

**Clinic Visits:** Study days 1 (8 hour visit), 2, 7, 14, 21, 28 (8 hour visit), 29, and 38 at 08:00 A.M.

**Follow Up Phone Call:** 30 days after dosing

(A follow up visit may be required for safety. If this occurs, you will be notified and compensated for your visit time and travel)

**Stipend:**

- ◆ **Screening:** \$75.00. (No compensation if urine drug/alcohol/cotinine screen is positive.)
- ◆ **Study:** \$4,250.00 (if selected and you complete the study).
